Short-term rentals in Eugene

University Area Planning – December 2024

Definitions (Lewis, Dinatale, and Parker 2018)

- Transient rentals or vacation rentals
- Units rented for less than 30 days
 - 50% are rented more 30 days per year









Regulations (Lewis, Dinatale, and Parker 2018)

- Restrictive zoning
- Incentive-based provisions
- Permitting
- Taxation
- Registration
- Review processes

Recommendations (Lewis, Dinatale, and Parker 2018)

- Collect and monitor data
- Define STRs by ordinance
- Decide which impacts are most concerning and regulate
- Vast menu of regulatory options

Registration requirement

(City Council work session on 7/13/2020)

Eugene Code (EC) 3.350 states that no person or business may own a short-term rental in the City of Eugene without registering the short-term rental with the City.

- Street address of the short-term rental,
- Local contact name and phone number of a person responsible for the short-term rental,
- Whether the short-term rental is owner occupied.

Oregon Lodging Tax Program


- The 2003 Oregon Legislature passed House Bill (HB) 2267 to establish a state lodging tax (1.5%).
- HB 2656, passed in 2013, expanded the list of who must collect and pay the tax. and requires transient lodging providers and transient lodging intermediaries to collect and remit taxes computed on the total retail price paid for occupancy of transient lodging.


City of Eugene Transient Lodging Tax (TLT)


• The City of Eugene's TLT, is a 4.5 percent tax (EC 3.772)
